This office has floated a Tender No. MD/MK/04/627 for procurement of AAA Rabbit Conductor vide NIT as per ref. (i) above which was opened on 15.04.19. You were a participant bidder in the Tender and as per procedure after opening of the Tender, the bid of various participant bidders were evaluated by the Tender Evaluation Committee constituted for the purpose. The documents related to the Financial Criteria for qualification of bidder were being scrutinised when suspicion was cast upon a certain letter of extending credit facility supposedly issued by the State Bank of India which you had submitted in your bid. The letter is mentioned at ref. (ii) above. To confirm the authenticity of this letter, the concerned Branch of State Bank of India namely the SME Branch, AIMO Building Pologround, Indore was contacted whereupon the Bank replied in writing that no such letter has been issued from their Branch. Thus, it was confirmed that you had submitted a forged document in your bid to meet the Financial Criteria of the Tender.

When this grave issue came to light, clarification was sought from your firm vide this office letter under ref. (iii) above. You replied after more than two weeks vide your letter under ref. (iv) above which strangely was dated 10.05.19 but was sent through mail by you only on 21.05.19. In your reply you bypassed the forgery issue but insisted that the figures provided by
