Non-refundable Tender Fee shall be credited through RTGS/NEFT by the bidder direct in current account of Executive Engineer, Electricity Transmission Division, Noida (Current Account Number - 2726002100049247, IFSC-PUNB0272600, Punjab National Bank, Sector-27, Noida) on or before scheduled end date of credit of Tender Fee & EMD, failing which the bid shall not be considered/opened. The scanned copy of pay-in-slip of Tender Fee, countersigned by the bidder is required to be uploaded.
2. EMD shall be either credited through RTGS/NEFT or submitted in the form of Bank Guarantee. In case of RTGS/ NEFT, EMD amount shall be credited by the bidder direct in the bank account mentioned in Sl. No. 1 above on or before scheduled end date of credit of Tender Fee & EMD, failing which the bid shall not be considered/opened. The scanned copy of pay-in-slip of EMD, countersigned by the bidder is required to be uploaded. In case of EMD submitted in the form of BG, it should be executed on a non-judicial stamp paper, in favour of Executive Engineer, Electricity Transmission Division, U.P. Power Transmission Corporation Ltd., Noida, in the prescribed proforma given in the bid document and scanned copy of the BG shall be electronically uploaded. The original Bank Guarantee shall have to be submitted in the office of Superintending Engineer, Electricity Transmission Circle, UPPTCL, 220 kV Substation, Sector-20, Noida before scheduled date and time of submission of bids, failing which such bid shall not be considered/opened.

Tender Fee and EMD shall be credited tender-wise separately by the Firm's account only i.e. there shall be no clubbing of Tender Fee and EMD amounts and submit its details as specified in tender notice and bid documents.
