#### INSTRUCTIONS TO TENDERERS

- 1. Bidders are advised to study the bid document carefully. Submission of bids against the tender notice shall be deemed to have been done after careful study and examination of the procedures, terms and conditions, Form-A/B, specifications, drawings etc. stipulated in the bid document with full understanding of its implications.
- 2. The bid document is available at e-procurement website <a href="http://etender.up.nic.in">http://etender.up.nic.in</a>. Interested bidders may view, download the bidding document, seek clarification and submit their e-bid online in two parts (viz. Part-I for satisfaction of prequalifying requirements etc. and Part-II being the Price Bid) up to the scheduled date and time of submission through uploading on e-procurement website <a href="http://etender.up.nic.in">http://etender.up.nic.in</a>.
- 3. Bidders are required to deposit Tender Fee and Earnest Money Deposit (EMD) through RTGS/NEFT/Bank Transaction in current account of Executive Engineer, Electricity Transmission Division-I, Moradabad (Account Number-10896364247, IFSC-SBIN0000682, State Bank of India, Civil Lines, Moradabad) as specified in Tender Notice. Tender Fee and EMD shall be deposited tender-wise separately i.e. there shall be no clubbing of Tender Fee and EMD with that of other tender.- The bidder has to submit the tender Fee & Earnest Money deposit confirmation by E-mail
- 4. After finalization of tendering process, the amount deposited against EMD of unsuccessful bidder shall be remitted in the account of concerned bidder through RTGS/NEFT by office of EE, ETD-I, MORADABAD. The bidder shall have no right to claim any bank interest against such EMD.
- 5. The bids shall be valid for a period of four (4) months from the scheduled date of opening of Part-I of the tender. Bids with lesser validity are liable to be rejected.
- 6. The bid should be strictly in line with the conditions, specifications and other requirements mentioned in the bid document. No deviations are permitted.
- 7. The bid shall be prepared and submitted strictly in accordance with the instructions contained in these specifications/bid documents. The bid shall be complete in all respects. **Each page of bid shall be signed by the bidders and stamped their seal.** All the required documents including Financial Bid shall be uploaded by the bidders electronically in the PDF format.
- 8. The bidder shall quote prices/rates against each and every item of Price Bid (Part-II) in manner as desired in bill of material/schedule of price. If price/rate of any item is not be quoted by bidder than the same item shall be assumed execution/supply free of cost for evolution of tender.
- 9. In case any portion of the bid documents is not clear to the bidder, clarifications must be obtained from Tendering Inviting Authority before submission of the bid. After the opening of the tender, the interpretations as made by Tendering Inviting Authority shall be acceptable to the bidder.
- 10. Any inconsistency or ambiguity in the offers made by the bidder shall be interpreted to the maximum advantage of the UPPTCL and disadvantage of the bidder. The bidder shall have no right to challenge the interpretation of the Tendering Inviting Authority/UPPTCL in all such cases and the same shall be binding on the bidder.
- 11. The bidder/contractor shall be solely responsible for all the documents submitted alongwith the bid or later on. If at the stage of finalization of tendering process or during execution stage or even at any stage, any of the documents are found to be fake/fabricated/false etc., action may be taken against the Firm/Contractor which may include Cancellation of Bid/Contract, forfeiting of EMD, Debarring and Blacklisting of the Firm/Contractor and any other legal action deemed fit in the eyes of Law.
- 12. The server time indicated in the e-procurement website <a href="http://etender.up.nic.in">http://etender.up.nic.in</a> will be the time by which the bid submission activity will be allowed till the permissible date and time schedule in the bidding. Once the bid submission period is over, the bidder cannot submit their bid. Bidder has to start the Bid Submission well in advance so that the submission process is completed within the scheduled period, failing which, it shall be the bidder's responsibility.
- 13. In the event of date specified for bid opening, being declared a holiday then the bid shall be opened on next working day at scheduled time.
