उ०प्र० पावर ट्रांसिमशन कारपोरेशन लि० के सेवानिवृत्त कार्मिकों द्वारा उनके सेवाकाल में की गयी अनियमितताओं हेतु विभागीय कार्यवाही किये जाने एवं तद्नुसार पेन्शन रोके जाने / कटौती किये जाने / प्रत्याप्ति किये जाने के सम्बन्ध में सी०एस०आर० के प्रस्तर 351—A तथा विभाग को हुई आर्थिक क्षिति की प्रत्याप्ति हेतु प्रतिमाह इसकी सीमा निर्धारित करने के सम्बन्ध में सी०एस०आर० के प्रस्तर 351—B, जो उ०प्र० शासन के वित्त (सामान्य—2) विभाग की अधिसूचना सं० जी—2—1008 / X—918—1958, दिनांक 06 जनवरी, 1961 द्वारा संशोधित किया गया है, को उ०प्र० पावर ट्रांसिमशन कारपोरेशन लि० में एतदद्वारा निम्नानुसार अंगीकृत किया जाता है:—

"351-A. The Governor (Substituted with The Board of Directors, U.P. Power Transmission Corporation Ltd.) reserves to himself the right of withholding or withdrawing a pension or any part of it, whether permanently or for a specified period and the right of ordering the recovery from a pension of the whole or part of any pecuniary loss caused to Government, if the pensioner is found in departmental or judicial proceedings to have been guilty of grave misconduct, or to have caused pecuniary loss to Government by misconduct or negligence, during his service, including service rendered on re-employment after retirement;

#### Provided that-

- (a) such departmental proceedings, if not instituted while the officer was on duty either before retirement or during reemployment,
  - (i) shall not be instituted save with the sanction of the Governor (Substituted with The Board of Directors, U.P. Power Transmission Corporation Ltd.)
  - (ii) shall be in respect of an event which took place not more than four years before the institution of such proceedings, and

- (iii) shall be conducted by such authority and in such place as the Governor (Substituted with The Board of Directors, U.P. Power Transmission Corporation Ltd.) may direct and in accordance with the procedure applicable to proceedings on which an order of dismissal from service may be made.
- (b) judicial proceedings, if not instituted while the officer was on duty either before retirement or during re-employment, shall have been instituted in accordance with sub-clause(ii) of clause (a), and
- (c) The Public Service Commission, U.P. shall be consulted before final orders are passed. (Omitted)

## Explanation-For the purposes of this Article-

- (a) departmental proceedings shall be deemed to have been instituted when the charges framed against the pensioner are issued to him, or, if the officer has been placed under suspension from an earlier dated on such date; and
- (b) judicial proceedings shall be deemed to have been instituted:
  - in the case of criminal proceedings, on the date on which a complaint is made, or a charge-sheet is submitted, to a criminal court; and
  - (ii) in the case of civil proceedings, on the date on which the plaint is presented or, as the case may be, and application is made, to a civil court.

**Note-** As soon a proceedings of the nature referred to in this Article are instituted the authority which institutes such proceedings shall without delay intimate the fact to the Audit officer concerned"

"351-B. In case in which a person is not withheld or withdrawn under Article 351-A but the amount of any pecuniary loss caused to Government is ordered to be recovered from the pension, the recovery should not ordinarily be made at a rate exceeding one-third of the gross pension originally sanctioned including any amount which may have been commuted"
